CERTIFICATE OF SERVICE FORM & REQUIRED DOCUMENTATION FOR REGISTRATION (AI or ET)**

The Certificate of Service form is designed to provide verification to the Breed Registrar that the parentage information submitted on the application is valid and can be verified by the signatures of all parties involved in the production of the offspring. This completed form is required to accompany the application for registration in the instances listed below:

- Page 2 of this form is to be completed and signed by the owner of the ewe(s) at the time of breeding by artificial insemination (AI) or embryo transfer (ET), **and** signed by the technician performing the procedure. Use additional forms as needed.
- If a ewe is sold as bred via an artificial insemination (AI), embryo transfer (ET), this completed form is to be given to the new owner at the time the ewe is sold so that they will be able to verify the information needed to the Breed Registrar to register their offspring.
Note: The owner of the ewe at the time of the breeding of the offspring shall be listed as the Breeder on the issued registration papers of the lamb(s), and the lamb(s) shall bear the Breeder's flock letters.

Note: For sires and dams not already in the NACFA Pedigree database, additional documents listed below will be required for registration of offspring resulting from importation of frozen semen or embryos.

- Pedigree listing registered sire/dam & grandsire/granddam from Country of Origin Registry.
- Imported AI Sires: Provide date of birth and birth type. (Note: NACFA database will mark animal "AI")
- A copy of the USDA required import permit.

Please submit the required items for documentation to the Breed Registrar prior to submitting any applications for registration of offspring.
